

**NOTICE OF  
DRAFT ACTION PLAN, COMMENT PERIOD, & FINAL PUBLIC HEARING  
MILLCREEK TOWNSHIP FY 2022 CDBG PROGRAM**

Notice is hereby given that Millcreek Township intends to make application to the U.S. Department of Housing and Urban Development (HUD) for FY 2022 Community Development Block Grant (CDBG) funds in the amount of *approximately* \$245,000.

Millcreek is entitled to the grant monies under the provisions of Title I of the Housing and Community Development Act of 1974, as amended. The tentative deadline to submit the application to HUD is May 13, 2022. Millcreek's CDBG program is administered by the Erie County Department of Planning.

Based upon a public needs hearing held on February 3, 2022 and a review of project requests, the Township proposes that its FY 2022 CDBG funds be used for the following activities:

- (1) \$187,000(+/-): Sidewalk Replacement Compliance Project - Phase II: – Remove existing non-ADA compliant sidewalks with 5' wide compliant concrete sidewalks along both sides of Highland Road from West 32nd St. to West 26th St. (SR 20).
- (2) \$28,000 (+/-): Millcreek Paramedic Service Equipment Purchase Project #2 – Purchase four (4) video laryngoscopes to be used on ambulances operated by Millcreek Paramedic Service. Video laryngoscopy is a relatively new technology developed to improve the success rate of tracheal intubation.
- (3) \$30,000 (+/-): General management, oversight, and coordination of Millcreek Township's CDBG Program.

A "Draft" Action Plan which summarizes the Township's CDBG program and the projects submitted/selected for funding is available for public review on Millcreek Township's website ([www.millcreektownship.com](http://www.millcreektownship.com)) and at the below listed locations from April 1 to May 1, 2022.
