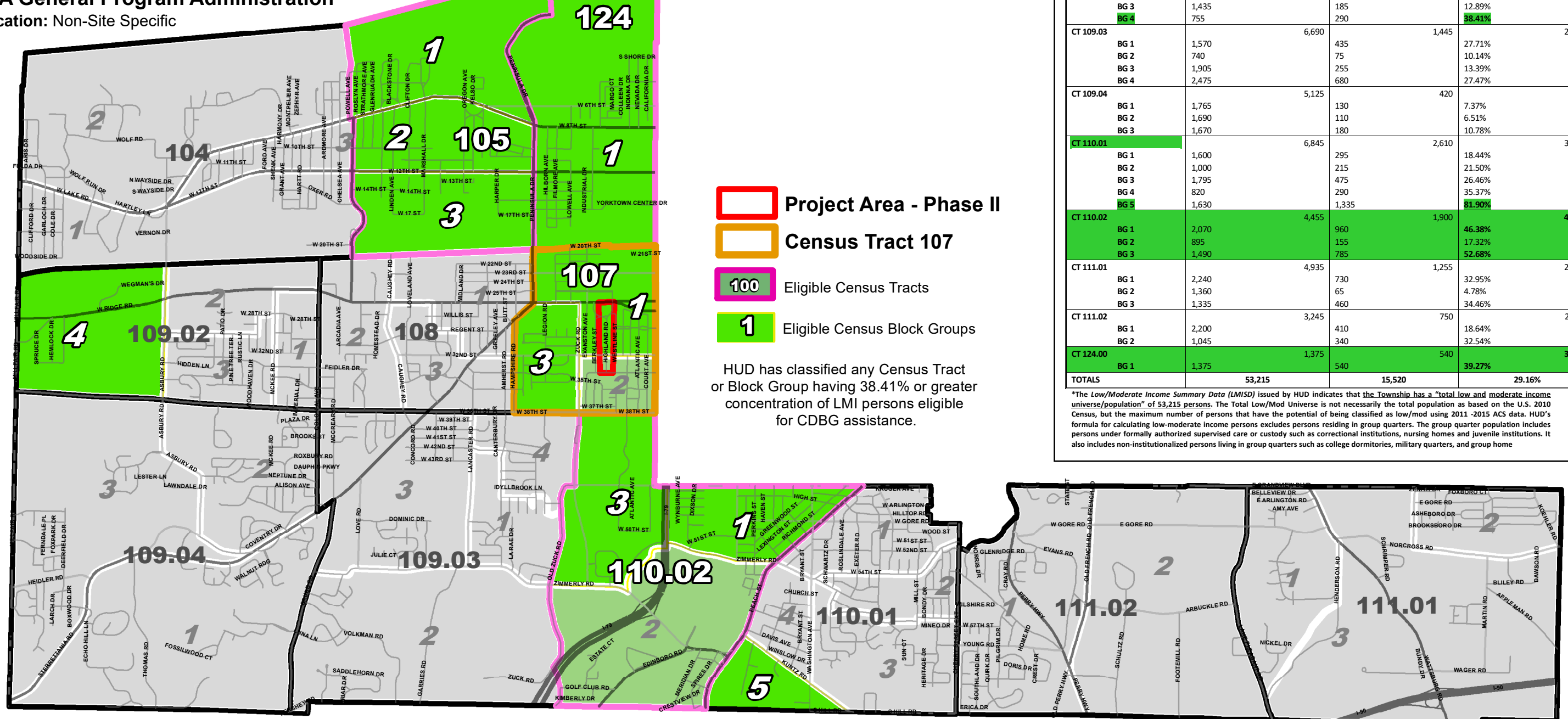

The group quarter population includes persons under formally authorized supervised care or custody such as correctional institutions, nursing homes and juvenile institutions. It also includes non-institutionalized persons living in group quarters such as college dormitories, military quarters, and group home.
